Volunteer Release and Waiver of Liability Form - Adult

This Release and Waiver of Liability (the “release”) executed today by profile owner above (hereafter referred to as Volunteer) releases United Way of the Lower Mainland (hereafter referred to as UWLM), a registered charitable organization organized and existing under the laws of the Province of British Columbia and each of its directors, officers, employees, and agents.

The Volunteer desires to provide volunteer services for UWLM and/or the general public and engage in activities related to serving as a volunteer. The Volunteer understands that the scope of the Volunteer’s relationship with UWLM is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that UWLM will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer’s services to UWLM.

1. **Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless UWLM and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to UWLM. I understand and acknowledge that this Release discharges UWLM from any liability or claim that I may have against UWLM with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to UWLM or occurring while I am providing volunteer services.
2. **Insurance:** Further I understand that UWLM does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of UWLM beyond what may be offered freely by UWLM in the event of injury or medical expenses incurred by me.
3. **Medical Treatment:** I hereby Release and forever discharge UWLM from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with UWLM.
4. **Assumption of Risk:** I understand that the services I provide may include activities that may be hazardous to me. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release UWLM from all liability.
5. **Photographic Release:** I grant and convey to UWLM all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by UWLM in connection with my providing volunteer services to UWLM.
6. **Confidentiality:** I consent to my information being shared with my match. I understand that I may have access to materials and sensitive information about clients, programs and community groups. I understand that I am expected to handle data appropriately and maintain the confidentiality, integrity, and availability of information. I acknowledge that the confidential information I acquire in performing the services of a volunteer is the exclusive property of UWLM and is provided to me

exclusively for UWLM business. I understand and respect the need for confidentiality and undertake and agree not to disclose same to any third party or use for any purpose other than UWLM business either during or after completion of my term as a volunteer of UWLM.

7. **COVID-19:** I acknowledge that I am not ill. I acknowledge that I have not knowingly been in contact with anyone who has been diagnosed with COVID-19. I acknowledge that I have not returned from abroad in the last three weeks.

8. **Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the Province of British Columbia and that this Release shall be governed by and interpreted in accordance with the laws of the Province of British Columbia. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
